AMATEUR MINOR ATHLETIC WAIVER AND RELEASE OF LIABILITY

In consideration of being allowed to participate in any way in the **Glenbrook South High School / AYSO Soccer Clinics** athletics/sports program, and related events and activities, the undersigned:

1.
